

# OGBL Student Fund

For the academic year 2021-2022, the National Committee of the OGBL has made available a credit of 50,000€ for scholarships to support the higher education of OGBL members' children.

Rules

## 1. Purpose of the OGBL Student Fund

The purpose of the OGBL Student Fund is to subsidize - through the granting of an annual scholarship - the higher education of the children of OGBL members. The National Committee of the OGBL sets annually the amount of the granted scholarship.

## 2. Eligibility criteria

### • The members

- i. A member of the OGBL, whose children are in higher education, can obtain a scholarship, if s/he is a member of the OGBL without interruption:
  - either since joining the union, if his/her age at the time of joining was less than 25 years old;

- or for at least 20 years, if s/he was at least 25 years old at the time of joining.
- ii. In the event of the member's death, account will be taken of the years that have elapsed since his/her death, provided that the surviving spouse has continued membership within three months.
- iii. In addition, the member must have paid within the 5 years preceding the demand the membership fee provided for by the statutes of the OGBL.
- iv. If a member has previously been a member of another union (attach certificate from the previous union), the years during which he was a member will be taken into account. However, this member must have been a member of the OGBL for at least five years without interruption.

### • Children:

For the Student Fund are considered as children:

- i. Legitimate children.
- ii. Children recognized by the civil registry
- iii. Children placed from a young age under the guardianship of an OGBL member
- iv. The children of a first relationship of the spouse of an OGBL member, as long as they live under his or her roof and are largely dependent on him or her.

### • Studies:

- i. The program and the course of study must be officially part of the higher education system of the country in which the studies take place.
- ii. The diploma awarded on completion of the course of study must be issued by or on behalf of a State authority competent in the field of higher education.
- iii. No scholarships will be awarded for repeated years/semesters.

## 3. Application form

The application form is published in the AKTUELL at least 3 months before the deadline for submission.

## 4. Deadlines

The deadline for the submission will be specified on the application form. No derogation will be granted, the postmark being proof.

## 5. Appeal

In the event of refusal of a request, the requesting member may refer the matter to the OGBL Supervisory Commission, which will take the final decision.

**A certificate of enrolment from the institution of higher education shall be attached to the application.**
